## PETITION FOR A WRIT OF CERTIORARI

I, Billy Ray Wilson, Petitioner, respectfully request the issuance of a writ of certiorari to review the judgement of the United States Court of Appeals for the Sixth Circuit.

### DECISION

The decision of the United States Court of Appeals for the Sixth Circuit is published (NOT RECOMMENDED FOR PUBLICATION), Sixth Court's Disposed Cases File: 21-5809 Billy Wilson v. Joseph Biden, et al. judge order filed – affirmed. Summary of Case not published on docket disclosure web site.

## STATEMENT OF THE CASE

My original filing with the Federal Court Eastern Kentucky sought the approval of United Nations General Assembly Resolution 181 to establish a Palestinian sovereign state alongside the sovereign Jewish Nation-State of Israel which the United States government continues to veto said statehood. Over the months, I provided historical and personal research data from employment in the Middle East which the authors dismissed; not recognizing as factual and to the point of altering my words of proof. Moreover, I find statements such as frivolous and others to be defamation.

Included in the documents regarding Palestinian statehood, I wrote the history of the fabrication of Judaism, Christianity, and Islam. No gods exist now or ever. In fact, I addressed the Declaration of Independence use of the word "Creator" and the scientific discoveries and true history revelations of the history of the ancient land known as Palestine.

The Hubble Telescope was a bonanza of discovers above our solar system and the newly launched Web Telescope has already generated new photos of new galaxies, habitable planets, etc.

With the change of government in Saudi Arabia to a Hebrew descent Royal Family, the House of Salman, all disciplines of the scientific and historical communities have discovered proof of human and non-human species travelling to and from Arabia beginning from the African continent. These findings confirm human movement from Africa and the return by Arab ethnic groups to the Arabian Peninsula before and after the existence of the Red Sea.

The history of Saudi Arabia is vivid with members of the Royal Family, important Arabs, and the wealthy marrying into wealthy Hebrew families. It took several years before the House of Salman assumed the realm of the Kingdom of Saudi Arabia. In fact, when Abdullah al-Saud, the founder of Saudi Arabia began his quest to build the Kingdom Saudi Arabia, he married a woman from multiple powerful, wealthy families, including Hebrews, on the Arabian Peninsula. His, Saud, association with Islam from the Wahhabi Family, the true Islam founders on the Arabian Peninsula. (A wife from every Saudi Province.) The final chapter in the development of Saudi Arabia was his relationship with the British Empire.

The reason I am so adamant about the Saudi history is as an U.S. State Department Foreign Sales Program with Northrop and McDonnell Douglas from September 1980 to June 1989, with breaks in the tenure, I used to have extremely candid conversations with the No.6 F-15 Royal Saudi Air Force's Squadron Religious Officer, other squadron officers, a Saudi Prince, members of an US Air Force F-15 training program (two Instructor pilots) and other Northrop and McDonnell Douglas employees. To this end, at arrival at the No. 6 Squadron, I professed to be of the Baptist faith but said faith was questioned every day; I became an atheist in 1998 after forced retirement for the Department of Veterans Affairs.

My religious beliefs were strong from seventeen years, from birth until I joined the air force on September 1960, based on growing in the Bible Belt of Southeastern Kentucky however from my military career throughout the United States and the international community, I came to question religious teachings and the existence of the Gods of Abraham daily. In fact, "the straw that broke the camels back" regarding the Gods of Abraham was the results of a request by the No. 6 Squadron's Commander: He asked me to write a paper on the history of Saudi Arabia for a previous commander who was going to attend the U.S. Military's War College, if not mistaken. I took the challenge resulting in long periods in the air base's library, the purchase of foreign and indigenous books on the kingdom, conversations with both Saudi military and civilians plus the many foreign nationals working at King Khalid. Wow! I learned about Muhammed's close Hebrew friend and their adventures prior to his alleged visions. (There are more mind-blowing drugs readily available in the Middle East than in the United States – no wonder individuals saw talking burning bushes.) Also, I recalled the teachings, during my youth, about the life of Abraham the Hebrew and the Hebrew continuous aggression against other ethnic Arab tribesman; the development of Judaism using an Egyptian Pharaoh's attempt to establish one Egyptian God; Saul aka Paul, a disciple of Jesus, was the author and delivery person of Christianity following the death of Jesus; Jesus was illiterate; and Rome's history of Jesus' death and theft of his body by grave robbers. The facts revealed to me; the Gods of Abraham are scams.

Research revealed and being developed; the multiple mining contracts let by the Saudi Government along with the tourist business which supplements the petroleum industry. The religious tourist is a primary reason, the Saudi Government keeps the flames burning against Iran. When Muhammed expired, Islam was divided into two sects: Sunni (Saudi/Wahhabi) and Shiites. The Saudis would lose billions if Islam became a Shiite religion instead of Sunni.

During my tenure at the No. 6 Squadron, Saudi and the US Air Force Instructor Pilots and contractors began a war with Yemen after finding new oil reserves in a Yemen province that borders Saudi's Asir Province; Hunt Oil Corporation was the oils founders and developers. Also, the Saudi's want one of Yemen's ports on the Red Sea and there are billions of dollars of unmined wealth of the bottom of the Red Sea.

In June 1989, I was worked one-end at the squadron and when I was leaving the squadron for my residence, I observed a group of senior USAF officers. I greeted them and asked if they would like to visit the squadron facilities. During the tour, the senior Colonel stated the Squadron Commanders office was larger than his at the Pentagon. Prior to departing, the senior officer told me he and the group was there to selected Saudi military installations that would

become Joint Saudi USAF installations. From a covert military assignment working with the US State Department, government intelligence agencies and other agencies, I realized we were going to a full war against Iraq. (Our squadron pilots were already flying sorties against Iraq and Iran air sorties.) I resigned and returned to the United States unemployed and unable to find employment in the Air Operations Career Field, i.e., civilian airline aircraft dispatcher.

I departed in June 1989 and in August 1990, the first USAF/Saudi Air Sorties launched from King Khalid against the country of Iraq.

Changing venues.

Following the Crusades, the spread of Judaism was warning however a member of the Rothschild Banking Dynasty, Judaism converts, funded and directed, in 1898, the activation of Zionism; wrote Lord Balfour, British Minister, to seek the United Nation's approval for the establishment of a Jewish Nation-State in Palestine; funded and dispatched a Zionist Army, following the end of the British Mandate in Palestine, to attack the non-aggressive people of Palestine; a primary land owner in Israel.
