SUBJECT: Wilson v, Biden, President of the United States, et al, USCA6 No. 21-5809 Withdrawal

Dear Mr. Levitan:

Received the Court's response packet on February 22, 2022, and I thank you for your professionalism in the dispatch and the contents thereof whereas based on the recent U.S. government actions at the United Nations and to our countrymen, I have concluded additional efforts would be without merit therefore, I am withdrawing my Law Suit, USCA6 No. 21-5809.

Mr. Levitan, I would be out of character, if I did not add comments based on covert and overt employment assignments primarily under the umbrella of the U.S. Federal Government

beginning with an U.S. Air Force Career, nine days after my seventeenth birthday, with the first duty station at Homestead Air Force Base, Homestead, FL from December 1960 to approximately August 1964.
